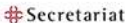

**Justice Philip Jeyaretnam**  
**Founding SCL(S) Chair 2002-2004**  
 Judge of the High Court

Justice Philip Jeyaretnam principally hears commercial and corporate disputes, including building and construction and shipbuilding matters.

He is also a member of the Judicial Service Commission, and the Presidential Council for Minority Rights.

Prior to joining the Bench, he specialised in commercial litigation and arbitration as a senior counsel. In 2020, the Law Society conferred on him the CC Tan Award.

Currently, he chairs the Construction Adjudicators Accreditation Committee and is on the boards of the Singapore Mediation Centre and the Singapore International Mediation Centre.

He has authored 19 books including the two-volume work *Law and Practice of Construction Contracts* (which is now in its 5th edition 2018); *Security of Payments and Construction Adjudication* (3rd edition of which is due for release in 2022), *Construction Contracts Dictionary* (now in its 2nd edition 2014) and the 2019 volume on Building and Construction Law in *Halsbury's Laws of Singapore* (2019).

On 1 November 2013, he was awarded the quinquennial Singapore Academy of Law Award 2013 for contributions in promoting and advancing the development of Singapore law. In 2018, he was conferred a National Day Award for services to the Singapore Academy of Law.
